10. **Overtime: If the Musician is requested to continue to provide music beyond the times set above, the musician will do so at a rate of \$50.00 per 1/2 hour if the musicians agree.**
11. **Cancellation by the Purchaser: If the Purchaser cancels this Agreement, for Whatever reason, the Musician will retain the Purchaser's Deposit.**
12. **Cancellation by the Musician: If, for reasons beyond control of the Musician, The Musician, must cancel this Agreement, the Musician will make every effort to locate substitute performers. If the Musician is unable to provide substitute Performers under terms acceptable to the purchaser, the Musician will return the Purchaser's Deposit.**

**13. Other Conditions:**

- a. One straight, backed, armless chair must be provided for each performer.
- b. Ample reading light must be provided to the musicians.
- c. Cases and other valuables belonging to the musicians must remain in their possession at all times.
- d. For services performed outdoors: In the event of rain, high winds, or temperatures below 60 degrees F. or above 95 degrees F., the musicians must be adequately protected from the elements or they must be allowed to perform indoors. Musicians must be protected from the direct sunlight.
- e. An audio or video recording of the performers may not be made without the permission of the performers.

**14. This agreement expresses the complete understanding of the Purchaser and the And the Musician, it replaces any former agreements or understandings related to it, and may not be altered without the written agreement of both the Purchaser and the Musician.**
